1. The items and part/model numbers listed in the table below, manufactured by your company, have been certified No Melt-No Drip or Flame Resistant (FR). Items certified as FR are inherently NMND. These items will be required to be recertified by 31 May, 2024, or this certification may be removed.

2. These items listed above are certified No Melt, No Drip (NMND) or Flame Retardant (FR). Acceptance of these certifications constitutes your guarantee to USAF customers that your quality process will ensure the product will repeatedly pass Air Force NMND or FR criteria, including Berry Amendment compliance, and other program specific requirements. No deviation is authorized to the end item or fabric construction fibers, fiber blend, filament, coating or treatments to the fabric or its individual fibers, or other physical properties for the style/part number without specific prior written approval from this office. Since the approved certified products are not necessarily conforming to one existing DOD material specification or end item configuration, and we approved specific variations from DOD Purchase descriptions, a reasonable range for +/- tolerances are expected in productions. Consistency within the tolerances of your company's product model/part number's physical properties are expected within reason. However, the test requirements for vertical flame test and melt observation shall be met as demonstrated capable in the results of product style number submitted for this certification. This certification expires three years from the date of this memo.
